AGREEMENT AND RELEASE

Undersigned's participation shall be considered a work made for hire and Producer shall be considered the author of the Work Products for purposes of copyright.
2. Producer shall have the right to edit any and all Work Products at Producer's sole discretion. Undersigned waives any and all rights of inspection and/or approval of such Work Products.
3. Producer shall have the right to use the Undersigned's name, likeness (photographic or otherwise), image, biography, voice, and performance in all media now known or hereafter devised, worldwide, in perpetuity in connection with the reproduction, transmission, broadcast, exhibition, distribution, packaging, and exploitation of the Work Products and in connection with the advertising, promotion, marketing, publicizing, and commercial exploitation of the Project; provided, however, that such usage shall not in any manner constitute or imply an endorsement by the Undersigned of any product or service.
4. The rights granted herein to Producer shall be for the benefit of Producer and all persons, firms, corporations, and entities who may hereafter acquire from Producer the right to transmit, exhibit, distribute, package, advertise, promote, market, publicize, and commercially exploit the Project.
5. Undersigned represents and warrants that Undersigned has the right to grant the rights granted herein and Undersigned is under no prohibition, disability, or restriction which would prevent Producer or any third part(y)(ies) from fully utilizing and exploiting such rights. No monetary compensation is or shall be due to Undersigned for the rights granted herein.
6. This Agreement and Release shall be governed and construed under and in accordance with the laws of the State of California and the sole and exclusive jurisdiction in connection with any matter arising out of this Agreement and Release shall be in the courts of the State of California, Los Angeles County or the Federal Courts located in the State of California, Los Angeles County.

The foregoing is acknowledged and agreed, and this Agreement and Release is executed, when the terms are accepted.
